Savannah McDermand was present to ask if the city would consider filling the ice skating rink if the weather turns cold enough. The council said they will consider filling it weather permitting.

It was reported the city received \$35,000 in grant money from the South Central Water Development District (SCWDD) with the possibility of receiving more in their next fiscal year.

Ed Konechne representing the Kimball Volunteer Fire Department was present to ask the council to surplus the 1988 Chevrolet pickup and the pump unit. Konechne is to get a description of the vehicle and three appraisals to surplus and advertise for sealed bids.

Motion by Bickner, second by Bilben to table the Banner chip seal project. All aye. Motion carried.

Water rates and surcharges were discussed. Finance Office Morley stated the surcharges of \$4.50 for water and \$15.65 for sewer will take effect in January. It was stated that in order for the city to receive revolving loan funds for the Kimball Main Street Project in the amount of \$1,095,000 for the sanitary sewer improvements and \$325,000 for drinking water system improvements from the Water and Natural Resources Board it was required the city adopt bond resolutions and the resolutions become effective and contingent upon the city establishing surcharges at a level sufficient to provide the required debt coverages.

The council also discussed options for increasing water rates due to Aurora Brule Rural Water raising their rates by 7%.

Motion by Janish, second by Bilben to table water rates until the first meeting in January. All aye. Motion carried.

Motion by Bickner, second by Janish to approve the second reading and approval of Supplemental Appropriation Ordinance 2024-09 to the Sewer Fund for \$16,000.00. Roll call vote. Janish-aye, Gough-aye, Blasius-aye, Chmela-aye, Bickner-aye, Bilben-aye. Vote of 6-0 motion carried. Ordinance printed separately.
